## Description of the PPE:

A jacket and trouser suit made in navy blue woven fabric, grey non-woven and grey woven fabric.

The PPE is made from the following materials according to the information supplied by the costumer:

- Navy blue woven fabric composition: 55% meta-aramid, 38% viscose FR, 5% para-aramid and 2% carbon with an approximate weight of 220±5 g/m².
- Grey non-woven fabric (jacket) composition: 100% aramid with an approximate weight of 150 g/m².
- Grey non-woven fabric (trouser) composition: 100% aramid with an approximate weight of 100 g/m².
- Grey woven fabric (lining) composition: 50% meta-aramid, 45% viscose FR and 5% para-aramid with an approximate weight of 115±5 g/m².
- Strips, stitched
- · Metal zip with metal pull
- Self-fastening tape
- · Plastic button and elasticated tape (trouser waistband)
- · Yarn for stitching

The PPE is available with the following variants:

• It can be manufactured in all the colours included in the range certified by Oeko-Tex

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
